

#### LIMITED CONSUMER WARRANTY

This product has been manufactured and tested to the highest quality standards by Hansgrohe, Inc. ("Hansgrohe"). This warranty is limited to Hansgrohe products that are purchased by a consumer in the United States or Canada after March 1, 1996, and installed in either the United States or in Canada.

#### WHO IS COVERED BY THE WARRANTY

This warranty extends to the original purchaser only. This warranty is non-transferable.

#### WHAT IS COVERED BY THE WARRANTY

The warranty covers only your Hansgrohe manufactured product. Hansgrohe warrants this product against defects in material or workmanship as follows: Hansgrohe will replace at no charge for parts only or, at its option, replace any product or part of the product that proves defective because of improper workmanship and/or material, under normal installation, use, service and maintenance. If Hansgrohe is unable to provide a replacement and repair is not practical or cannot be made in timely fashion, Hansgrohe may elect to refund the purchase price in exchange for the return of the product.

#### LENGTH OF WARRANTY

Replacement or repaired parts of products will be covered for the term of this warranty, as stated in the following two sentences. If you are a consumer who purchased the product for use primarily for personal, family or household purposes, this warranty extends for as long as you own the product and the home in which the product is originally installed. If you purchased the product for use primarily for any other purpose, including, without limitation, a commercial purpose, this warranty extends only (i) for 1 year, with respect to Hansgrohe & Commercial products, and (ii) for 5 years, with respect to AXOR products.

#### THIS WARRANTY DOES NOT COVER, AND HANSGROHE WILL NOT PAY FOR:

- A. Conditions, malfunctions or damage not resulting from defects in material or workmanship.
- B. Conditions, malfunctions or damage resulting from (1) normal wear and tear, improper installation, improper maintenance, misuse, abuse,
- negligence, accident or alteration; (2) the use of abrasive or caustic cleaning agents or "no-rinse" cleaning products, or the use of the product in
- any manner contrary to the product instructions; or (3) conditions in the home such as excessive water pressure or corrosion.
- C. Labor and other expenses for disconnection, deinstallation, or return of the product for warranty service
- (including but not limited to proper packaging and shipping costs), or for installation or reinstallation of the product.
- D. Accessories, connected materials and products, or related products not manufactured by Hansgrohe.
- E. Any Hansgrohe or AXOR product sold for display purposes.
- F. Hansgrohe Water Filtration System is subject to a 1-year limited warranty. Warranty does not include replacement filters.

HANSGROHE SHALL NOT BE LIABLE TO PURCHASER OR ANY OTHER PERSON FOR ANY INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, ARISING OUT OF BREACH OF THIS WARRANTY OR ANY IMPLIED WARRANTY (INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY).

TO THE EXTENT PERMITTED BY LAW, ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE DURATION OF THE EXPRESS WARRANTY.

Hansgrohe, Inc. is dedicated to customer satisfaction. If for any reason you must return a product to us, please follow our Return Policy for best warranty service. Product should not be returned for credit or replacement without prior written authorization from Hansgrohe, Inc. Any product returned and received by Hansgrohe without prior written authorization will not be accepted. You will be notified and the items will be returned at your expense.

Credit for the return of Masco Canada Limited products will be allowed when authorized by Customer Service subject to the following conditions:

- 1. A Returned Good Authorization (RMA) form must be provided to the customer and the approved RMA paperwork must be included with the returned product.
- 2. Return Goods Authorization will be effective for 60 days after issuance.
- 3. Products and Packaging must be in resalable condition.
  - a. Discontinued and/or obsolete product not in the current price list, or product announced for obsolescence and/or discontinuation cannot be returned.
  - b. We will honor the price on the last invoice, otherwise list and discount.
  - c. Product purchased more than 18 months ago cannot be returned.
  - d. Only product with current finishes can be returned
  - e. Where possible product packaging must be factory-sealed.
  - f. Display products cannot be returned under any circumstances.
  - g. We reserve the right not to accept product that will put Masco Canada in an excess inventory position.
  - h. Products and packaging which are customer fault defective, that have had anything removed from the box and are now non-saleable goods will be scrapped and no credit will be issued.
- 5. All returns must be shipped freight prepaid; no credit will be given for freight charges.
- 6. Non-Masco products will not be returned to the sender and will be destroyed upon receipt. No credit will be issued for non-Masco products. (Sender will receive notification of error on shipment.)
- 7. If product is being returned as a result of an order entry or shipping error, the RMA will be issued with no re-stocking charge and will be shipped prepaid by Masco Canada.
